| <p><u>The school will do its best to...</u></p> <ul style="list-style-type: none"> • Provide an environment which has been risk assessed in response to the COVID-19 infection; • Adhere to the social distancing rules as set out by the government as much as we reasonably can both in and out of school; • Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs; • Contact parents/carers if your child displays symptoms of COVID-19; • Inform you if staff or children in your child's 'bubble' show symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days or until the test comes back negative; • Continue our clear and consistent approach to behaviour management for children as set out in the Behaviour Policy alongside the expectations outlined in this agreement; • Communicate between home and school through newsletters, email and the school website. | <p><u>To help my child at school, I know and understand that...</u></p> <ul style="list-style-type: none"> • If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family, I will get them tested and I will let the school know as soon as possible via telephone or email; • If my child, or another child in the 'bubble', shows symptoms of COVID-19 at school, I will collect my child from school immediately; • When dropping my child off and picking them up, I will adhere to the 2 metre social distancing rules. • I will be on time when dropping off and picking up my child; • My child must not bring any items into school with them or take items home from school unless previously agreed with a member of staff; • I will send my child into school with appropriate clothing for inclement weather and clothing which reduces the need for close adult assistance (e.g. shoes which children are able to tighten themselves and don't cause blisters); • If providing a home packed dinner, I will send my child into school with a lunch/water bottle, which can be consumed/refilled with limited adult assistance (e.g. avoiding sending food, which is tricky for a child to unwrap). • I will need to remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully; • I will teach my child how to wash their hands properly; • I will remind my child about the importance of 'catch it-bin it-kill it' for coughing and sneezing. • I will not be allowed into the school without a prearranged appointment - make appointments via telephone or email; • I need to support the whole school community in their efforts to create an 'as safe as possible' environment; • I will read all messages/emails that are sent home within 48 hours; • I need to inform the school immediately of any changes to parents/carers and emergency contacts details; • If my child is deemed unsafe, they will be sent home and cannot return to school until they can be safe so that we can protect the whole school community. • I understand that if my child is unwell at school, they will be immediately isolated from other children and staff. | <p><u>Pupils will do their best to...</u></p> <ul style="list-style-type: none"> • Adhere to the social distancing rules in class, in the toilets, in corridors and in the playground; • Stay in my 'bubble' all day - not mixing with any other children in the school; • Tell an adult if I feel unwell; • Not bring things into school from home, or take things home from school; • Only use the equipment provided to me by school; • Only enter and exit the school building from the designated gate; • When coughing and sneezing, use inside of elbow or tissue (catch it-bin it-kill it); • Wash hands regularly - use soap and water for 20 seconds/ hand sanitiser; • Behave well at all times to maintain the safety of myself and others; • Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe. |
